


Strategic under-explored project 15km N of Kalgoorlie




## Gidji JV – Gold targets

# Potential for multiple supergene and/or primary gold deposits within the Boorara Shear Zone

- Multiple large aircore gold anomalies outlined
  - Marylebone
  - Blackfriars
  - Highway-Piccadilly
  - Railway
- 8-Mile potential extension to Runway (300koz Au)
- The Jog dilational jog in Boorara Shear Zone
- Working to refine targets for further bedrock drilling





### Gidji – Nickel potential


- 15km strike of "Highway Ultramafic" host to Scotia and Saints nickel deposits
- Limited previous nickel exploration
- Strongly elevated Ni and Cu aircore results
  - 7m @ 0.70% Ni, 148ppm Cu (EOH)
  - 6m @ 0.63% Ni, 127ppm Cu
  - 10m @ 0.52% Ni, 86ppm Cu
- Pt and Pd indicates nickel sulphide potential
- Multiple prospective basal contact targets
- EM and bedrock drill testing planned

# Under-explored high-grade gold opportunity


- 40km E of Kalgoorlie close to various gold mining/processing infrastructure
- Large aircore gold footprint on salt lake
- Multiple high-grade gold results at mafic/granite contact – "Glandore East"
- UAV magnetic survey highlights multiple NE-trending mineralised structures
- Similar geology and structure to Majestic and Imperial deposits (~0.5Moz Au)



### **Glandore East**




- Multiple NE-trending structures at granodiorite/mafic contact
- High-grade bedrock gold results beneath large aircore gold footprint
- Significant strike potential open at depth
- Detailed magnetics and further drilling planned





## Whaleshark Copper-Gold Project

- Proterozoic BIF and granite under Carnarvon Basin sediments
- Basement depth ~100m
- MMI soil anomalies
- Geochemical signature similar to known IOCG deposits
  - 1. Aircore anomalism like **Ernest Henry**
  - 2. REE signature like **Prominent Hill**



### 1. Geochem anomalism like Ernest Henry



Anomalous Cu, Au, Co, Mo, U and W at basement unconformity



### **Bangemall Projects**

#### First mover in emerging mineral province


- Multiple crustal-scale structures/fluid conduits
- REE potential
  - Multiple REE carbonatite discoveries nearby
  - New magnetic /radiometric anomalies at Dooley Downs
- Ni-Cu-PGE potential
  - Proterozoic dolerite dykes/sills
  - Regional stream sed/soil anomalies
  - Late-time EM conductors



## **Bangemall - Dooley Downs REE targets**


- Multiple potential REE intrusions identified from magnetic/radiometric survey
  - Magnetic lows
  - U/Th anomalism
- Follow-up geophysics and sampling planned




### Bangemall – Mt Vernon

- Large Ni-Cu-PGE soil anomalies
- Multiple late-time EM conductors
- Proterozoic dolerites
  - Narimbunna (e.g. West Musgraves)
  - Mundine Well (e.g. Mangaroon Ni/PGE's)
- Mapping/sampling planned in 2023
