## *Potential for a large shallow IOCG discovery*


- Prot. BIF and granite under Carnarvon Basin

## What we know so far

- ✓ Shallow basement
- ✓ Proterozoic granite intrusion
- ✓ Fe-rich rocks nearby
- ✓ Strongly anomalous **IOCG** geochemistry
- ✓ Sodic and potassic alteration
- ✓ Gravity anomalies



# Lang Well – REE potential




- Large historic auger anomalies (**Au** and **Samarium**)
- Elevated **La** and **Ce** results in historic aircore drilling
- Only 1 aircore sample previously assayed for **REE's**
  - **4m @ 1,500ppm TREO**
- Recon aircore drilling completed - assays pending



# Gidji JV

*“The cheapest house on the best street”*


- 15km N of **Kalgoorlie** via major highway
- 15km strike of **Boorara Shear Zone** host to:
  - **Paddington/Panglo**
  - **Bardoc deposits**
  - **Boorara/Golden Ridge**
- Limited effective historical drilling due to transported cover and paleochannel sediments
- Proximity to multiple gold processing plants
- **Nickel sulphide potential** in Ultramafic units



# Gidji JV – gold targets


*Potential for multiple supergene and/or primary gold deposits within the Boorara Shear Zone*

- Shallow gold “Exploration Target” at **Marylebone**
  - **1.4 to 3.2Mt @ 1.2 to 1.5g/t Au\***
- Multiple other large aircore gold anomalies outlined
  - **Blackfriars**
  - **Highway-Piccadilly**
  - **Railway**
- Refining bedrock targets for further deeper drilling



 + multiple mineralised contacts




- Paddington**
- Discovered in **1982** beneath historic workings
  - Dilational jog in **Boorara Shear Zone** crosscut by later N-S faults
  - Quartz veins in **dolerite** between Black Flag sediments and mafic/UM sequence
  - 30m depleted zone above deposit
  - Approx. **4Moz Au** produced since **1985**

# Glandore East



- Multiple narrow **high-grade gold** results beneath **very large aircore footprint**
- Similar geology and structure to **Majestic** and **Imperial** deposits (~0.5Moz Au)
- Magnetics and further drilling planned




