NICKEL AND COPPER SULPHIDES CONFIRMED AT MOUNT VERNON

- **Micro-XRF analysis of Mount Vernon RC drill samples confirms presence of pentlandite and chalcopyrite in differentiated Kulkatharra Dolerite sills**

Miramar Resources Limited (ASX:M2R, “Miramar” or “the Company”) is pleased to advise that mineralogical analysis of selected samples from EIS co-funded RC drilling at the Company’s 100%-owned Mount Vernon Project has confirmed the presence of nickel (Ni) and copper (Cu) sulphides (pentlandite and chalcopyrite respectively) within the Kulkatharra Dolerite for the first time.

Miramar’s Executive Chairman, Mr Allan Kelly said the new data confirmed the Bangemall as a mineral province with the potential to host large Ni-Cu-Co-PGE deposits.

“We targeted the Bangemall Projects on the basis of several regional-scale data sets which indicated the potential for Norilsk-style mafic intrusion hosted magmatic Ni-Cu-Co-PGE mineralisation,” he said.

“Our rock chip sampling and drilling provided evidence of the presence of differentiated dolerite sills containing mafic cumulate rocks and now, for the first time, we have confirmed the presence of nickel and copper sulphides within our projects,” he said.

“This new data proves we are on the right track,” he said.

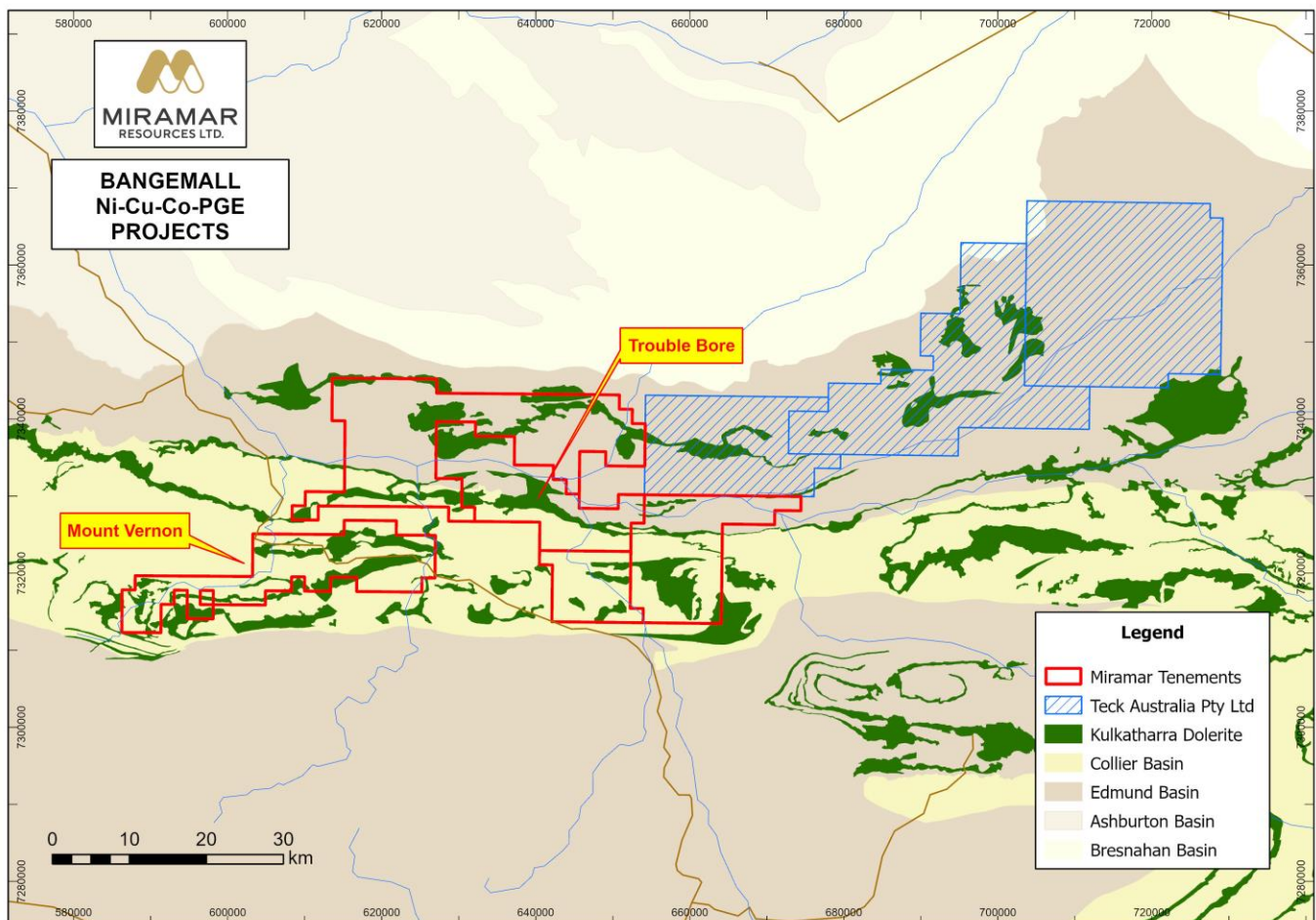


Figure 1. Miramar’s Bangemall Projects



Micro-XRF analysis

Selected samples from the recent EIS-co-funded drilling campaign at Mount Vernon were sent for a trial of “Micro-XRF” analysis at Portable Spectral Services, in West Perth.

Six samples were selected where litho geochemistry data indicated the presence of mafic cumulate rocks within the differentiated Kulkatharra Dolerite sills.

The aim of the Micro-XRF analysis was to:

- examine the mineralogy of the samples including olivine, pyroxenes, and sulphides
- determine which sulphides were present
- look for evidence of zoning in pyroxenes and/or spinels, if possible

According to Portable Spectral Services, the samples contain olivine, clinopyroxene, orthopyroxene and “at least four notable sulphide phases” including:

- **Pentlandite – nickel sulphide**
- **Chalcopyrite – copper sulphide**
- Pyrrhotite
- a “sub-surface Zn-phase” which may or may not be sphalerite

Table 1 shows a summary of the mineralogical analysis of the six samples highlighting the presence of pentlandite and chalcopyrite in all but one of the six samples.

No conclusions could be made about potential zoning due to limitations in the resolution of the micro-XRF. The Company will look at other methods to determine this information.

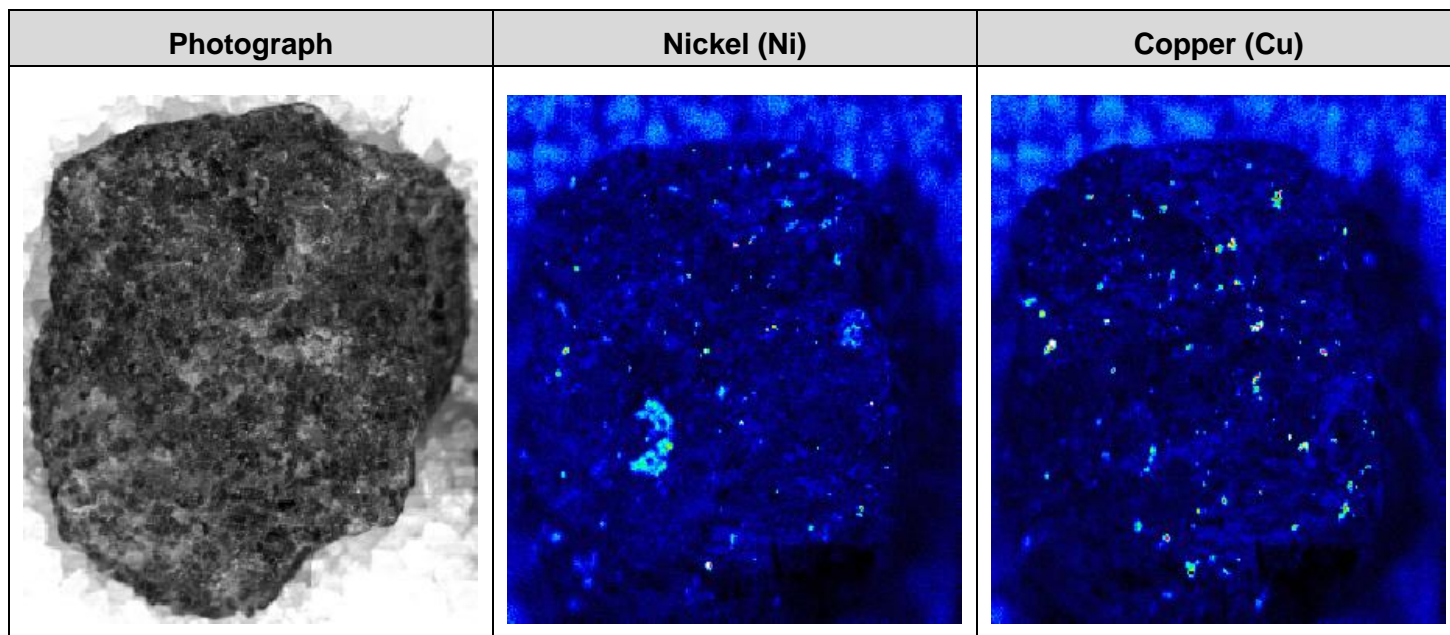


Figure 2. MVR003 (79-80m) photograph (left) and nickel and copper “maps” where bright spots indicate high values. (Field of view approximately 12mm).

Figure 2 shows example “maps” for nickel and copper in sample MVRC003 (79-80m) which contained pentlandite and chalcopyrite.

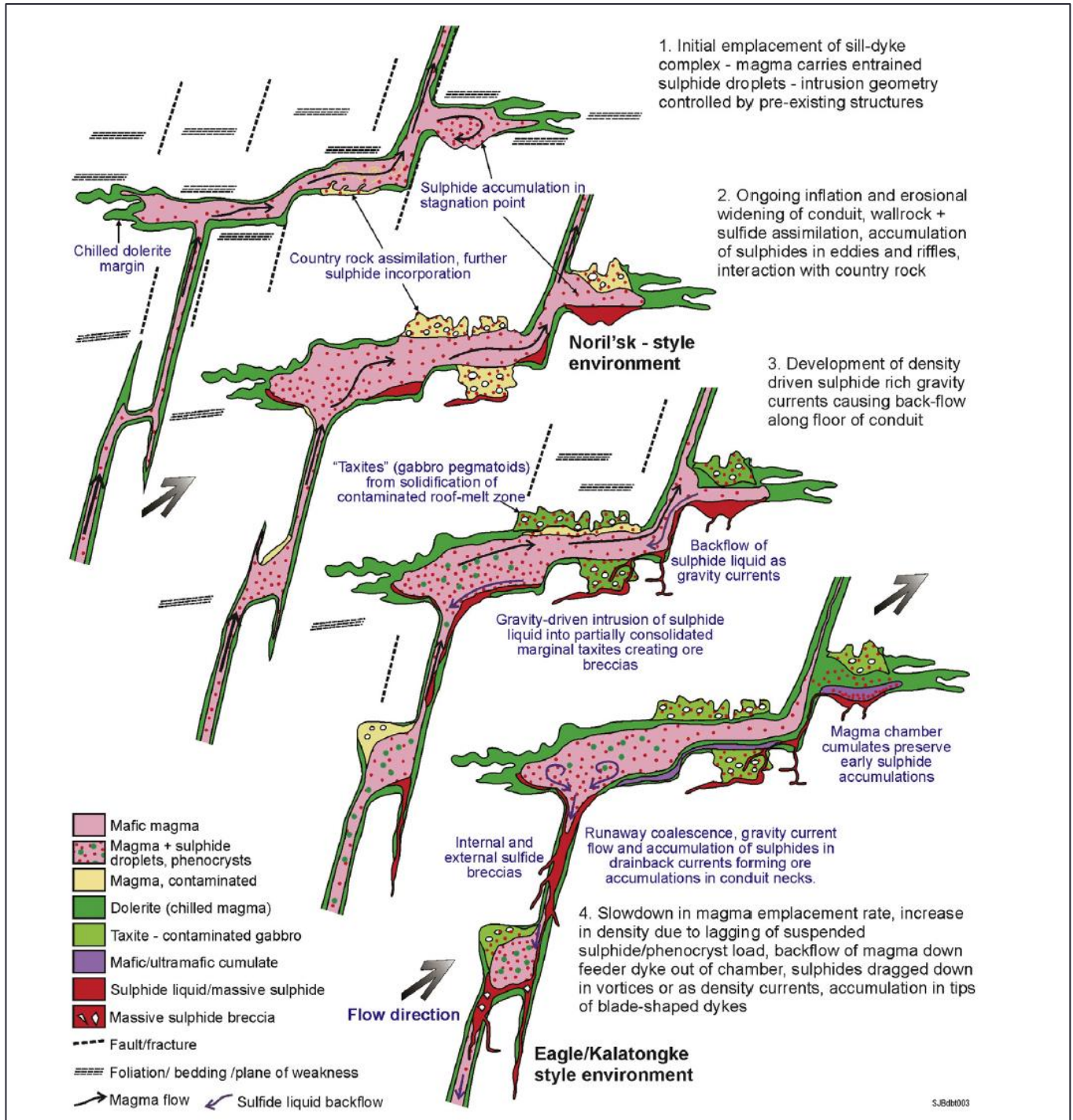
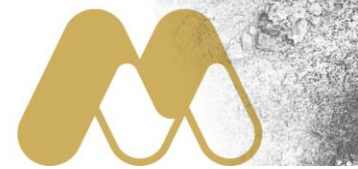
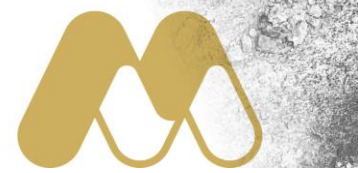


Figure 3. Schematic illustration of an idealised magmatic plumbing system, showing a hypothetical sequence of events leading to the development of Noril'sk style, Eagle–Kalatongke style and Voisey's Bay style mineralisation. (Barnes et al, 2015)

The new data confirms that the mafic magma has carried nickel and copper sulphides (pentlandite and chalcopyrite), whilst the presence of mafic cumulate rocks indicates the potential for depositional sites where these nickel-copper sulphides could accumulate (Figure 3).

Next Steps

The Company continues to be excited about the potential to discover a large mafic-hosted magmatic Ni-Cu-Co-PGE deposit within its Bangemall tenement holding and is planning further work including:

- Signing up to the CSIRO’s “Indicator Minerals for Magmatic Nickel Sulphides” Study
- Further analysis of rock chip and drilling samples to determine the presence of zoning in pyroxenes, which is a key indicator a fertile Ni-Cu-Co-PGE mineral system
- Completing a diamond drill hole at the high-priority Trouble Bore target, which will be co-funded under WA government’s Exploration Incentive Scheme (EIS)
- Applying for EIS funding for regional geophysical surveys to cover the Mount Vernon, Trouble Bore and new tenement applications.

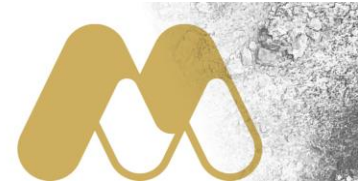

About the Bangemall Projects

Miramar's 100%-owned Bangemall Project comprises granted Exploration Licences and Applications covering approximately 1,230 km² within the Gascoyne region of Western Australia.

The Proterozoic Edmund and Collier Basins have been intruded by numerous 1070Ma aged Kulkatharra Dolerite sills, part of the Warakurna Large Igneous Province, and the same age as the Giles Complex which hosts the large Nebo and Babel Ni-Cu deposits in the West Musgraves.

The region has been identified by the Geological Survey of Western Australia, Geoscience Australia and the CSIRO as having high prospectivity for Ni-Cu-PGE mineralisation associated with the Kulkatharra Dolerite sills, similar to the giant Norilsk-Talnakh Ni-Cu-PGE deposits in Russia.

Since 2020, Miramar has built a strategic land position in the Bangemall region, focussing on areas containing key ingredients and/or regional-scale indicators for Proterozoic mafic intrusion hosted Ni-Cu-PGE mineralisation including:

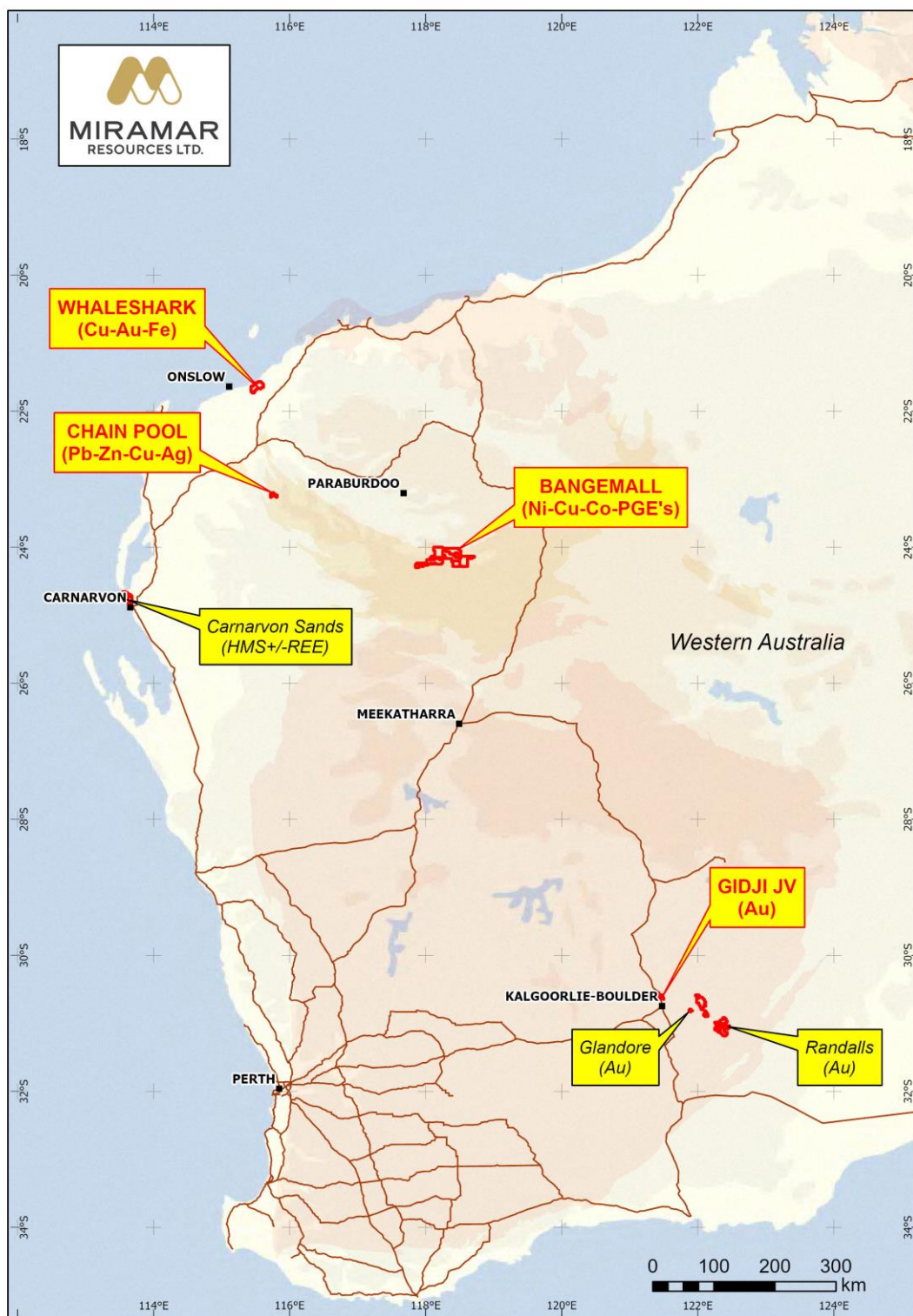
- 1070Ma Kulkatharra Dolerite sills – source of Ni, Cu +/- PGE's
- Proximity to major crustal-scale faults - potential plumbing systems
- Sulphidic and/or evaporitic sediments - potential sulphur source
- Regional-scale geochemical anomalism (GSWA regional geochemistry)
- Regional-scale EM anomalism (2013 Capricorn AEM Survey)

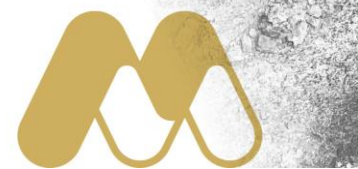
